### The main objectives of Pacific Christian Education Ltd

- a) Contribute to the education facilities of the Commonwealth of Australia by establishing and maintaining in such suitable places which may be thought convenient, preschools and primary and secondary and other education institutions of a high standard for the purposes of achieving the Objects of the Company.
- b) Provide Christian Education.
- c) Provide religious services, worship and teaching in conformity with the Statement of Faith.
- d) Build and maintain Christian Community with an ethos of love and grace by:
  - I. facilitating co-operation between members of the School Community;
  - II. providing opportunities for constructive communication between members of the School Community;
  - III. providing regular educational and social opportunities for close relationships to be formed between members of the School Community;
  - IV. involving members of the School Community in the work and operations of the Company; and
  - V. for schools providing a Christian Education to children of Aboriginal descent, by connecting with the local Christian Aboriginal Elders;
- e) As a consequence of a conviction that all people are created in God's image, in any educational facility it operates, to include, accept and value all children, including children with different categories of special needs, such as physical, intellectual and learning needs, on the understanding and condition that the enrolment of any child with special needs in any educational facility operated by the Company will be at the absolute discretion of the Company, bounded by the limitations of resources and capabilities of that educational facility in providing for any particular special need at any particular time.
- f) establish and maintain relations with bodies having similar objects throughout the world; and
- g) make donations for charitable purposes.

### Statement of Faith

The Statement of Faith of the Company is as follows:

- (a) The Bible is God's Word, inspired by the Holy Spirit and without error in the original writings. It is our sole authority and absolutely binding in all matters of faith and conduct.
- (b) There is one holy God, existing eternally as Father, Son and Holy Spirit.
- (c) He is the Creator of all things visible and invisible. Jesus Christ is the Son of God who became man through conception by the Holy Spirit and virgin birth and was without sin.
- (d) The Holy Spirit convicts the world of guilt in regard to sin, righteousness and judgement.
- (e) Satan is the originator of all evil and through him sin was introduced into the world after the Fall of Adam and Eve. Man is, by nature and practice, a sinful creature and is unable, by any personal merit or works, to meet the standards of a holy God.
- (f) In love, Jesus Christ voluntarily suffered the penalty of death by crucifixion for the sin of the whole world. He was buried and arose from among the dead on the third day thus signifying God's acceptance of His sacrifice. He is now seated at the right hand of God. By personal faith in Christ one can know the complete forgiveness of sins, be reconciled to God, become a member of the family of God and receive eternal life. Those who do not accept Jesus Christ as Saviour will be separated from God eternally.
- (g) Christ lives in every Christian's life by the Holy Spirit from the moment he is born again into God's family. The Holy Spirit guides, instructs and empowers the believer for godly living and service.
- (h) The Lord Jesus Christ will return in person to receive all believers to himself and to set up his kingdom. At that time all believers will be united with Him eternally. Then there will be a new heaven and a new earth in which God's sovereignty will be unchallenged.
